Policy on Green Campus

1. Introduction

Sadhan Chandra Mahavidyalaya is committed to promoting environmental sustainability and creating a green campus. This Green Campus Policy aims to integrate sustainable practices into all aspects of campus life, fostering a culture of environmental responsibility among students, faculty, and staff.

2. Objectives
