2. Application Form: Students must complete the prescribed application form and submit it along with required documents.
3. Submission Deadline: Applications must be submitted by the specified deadline.

Policy:

West Bengal Government Scholarships:

1. Swami Vivekananda Merit-cum-Means Scholarship (SVMCM):
Eligibility: Students who have secured 75% marks in Higher Secondary or equivalent exams and are pursuing undergraduate or postgraduate courses.
Application: Students must apply online through the official scholarship portal.
2. Kanyashree Prakalpa:
Eligibility: Female students between 13 to 18 years of age, unmarried, and enrolled in educational institutions.
Application: Applications are facilitated through the school or college authorities.
3. Aikyashree Scholarship:

Application: Applications are submitted through the National Scholarship Portal.
